

Level 3 Lead Adult Care Worker Apprenticeship Course Fact Sheet

About: The programme prepares individuals for frontline care duties with vulnerable adults. Individuals typically work with users of services in a range of care and support settings including day care, residential care, dementia services, learning disabilities services and also in individuals' own homes. The programme is also designed for care workers taking on responsibility for supervision, guidance and frontline leadership.

Typical roles include Care Officer, Care Supervisor, Senior Care Worker, Senior Support Worker, Community Support Worker, Community Outreach Worker.

As part of the Lead Adult Care Worker learners will complete the Diploma in Adult Care in part fulfilment of the Apprenticeship.

Length: The course is 18 months plus 3 months for the Apprenticeship Assessment (AA). The AA is an independent assessment that takes place at the end of the apprenticeship. It is carried out by another organisation. Learners need to allocate **6 hours a week** to the apprenticeship, which is split between teaching and workshops, self-paced learning and the practical application of skills.

Model of Delivery: The apprenticeship is delivered through monthly workshops, some face to face, some online. Each learner is allocated an assessor who will work with them and support them throughout the apprenticeship journey. There will also be monthly 1:1 meetings between learner and assessor and 12 weekly periodic reviews between assessor, learner and line manager.

Modules and Content:

The programme comprises a total of 58 credits. 39 credits arise from the mandatory units outlined below. The remaining 19 credits arise from optional units. Each employer may tailor the optional units to meet the care needs of clients within their care setting

- Understand the principles of online safety
